## Appendix 3B Notice

### Completion of SPP – Issue of New Shares

Rimfire Pacific Mining NL (ASX:RIM) (“Rimfire” or “The Company”) is pleased to announce information concerning the recent Share Purchase Plan (SPP) which has now closed.

The response to the SPP from shareholders was strong, resulting in greater than anticipated demand, with 183 holders participating in the SPP.

The Board is very encouraged by the level of support shown towards the Company and its work programs. Accordingly, the Board **has decided to exercise its discretion under the terms of the SPP and accept the oversubscription amount to the SPP, thus allowing all subscribers to participate.**

The Company had originally estimated the SPP would provide approximately \$750,000 in new capital, but **the final amount received and now accepted is approx. \$1.247m.** This is an excellent result for the Company.

The SPP when combined with the recent placement (which was also completed at 4.3 cents per share and raised \$2.034m) **provides approx. \$3.281m in additional capital to the Company,** leaving the Company well funded heading into 2014. Associated costs to both issues were minimal.

#### **The final position on the recent SPP is as follows:**

1. A total of **29,012,426 RIM fully paid shares** will be issued at **4.3 cents** per new ordinary share providing approx. **\$1.247m** of additional capital to the Company.
2. Allotment of the total number of new ordinary shares occurs **27<sup>th</sup> September 2013.**

The Company again expresses its gratitude for the participation and ongoing support shown in the SPP by shareholders.

It should also be noted that drilling results at the Roadside location will be available during the next 3 weeks. Additional drilling will be underway SW of the Sorpresa Gold and Silver Project at Fifield NSW and the Company looks forward to providing further updates on progress in due course.
