8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Yes – at the end of March 2022 Rimfire had a cash balance of \$452k, and an additional \$269k which is held in trust separately to the Company's cash balance and is used to pay for activities conducted on the Avondale and Fifield Earn-in Projects.

Our exploration partner, Golden Plains Resources Limited (GPR) who sole funds all exploration programs for the Avondale and Fifield projects, has recently committed to an additional \$3.0M of exploration expenditure under the Earn-in Agreements and proceed to Year 2 of the Avondale Project Earn-in and Year 3 of the Fifield Project Earn-in.

As part of GPR's commitment to Year 3 of the Fifield Project Earn-in GPR **paid the Administration Fee of \$0.3M directly to Rimfire subsequent to end of Quarter in April 2022 (included in the \$3.0M commitment above).**

With the above commitments by GPR, the Company is continuing its operation on the fully funded Earn-in Projects.
